

Manufacture and sale



Prohibition

Manufacture for sale, sell or stock or exhibit or offer for sale or distribute any drug

- Except under license
- In accordance with the conditions of license

Present Regulatory System




- Organized system for health care management
- System to keep away entry of spurious, misbranded or adulterated drugs in the market
- Avoid self medication, enable use of medicines with utmost care to minimize the risks to the health of the patients
- Ensure the traceability of the medicines from the manufacturer, distributors, retailers up to the point of use to enable effective recall, wherever and whenever required

Menace of Counterfeits



- Current regulatory framework focuses on spurious drugs, not on counterfeits
- Spurious Drug: A drug which does not contain any active medicine or is manufactured by unlicensed/unauthorized/fictitious manufacturer or is not of standard quality
- Counterfeits: May contain a valid active and or may be manufactured by a licensed factory. But are still illegitimate on account of
 - Trademark or copy right violations
 - Manufacture at or Distribution through unauthorized factories/channels
- Counterfeits carry financials and reputational costs for all stakeholders (manufacturer, regulator, consumer, prescriber, government at large)



Extent of counterfeits




- Perceptions (lacking evidence) vary across a spectrum with some sources citing a rate of incidence up to 12-14%
- There has been no expansive or authoritative survey for counterfeits; however, surveys for spurious drugs exist
- Most recent findings are from National Drug Survey:2016-18

Parameter	Finding
Samples Drawn	47,000
Not of Standard Quality	3.16%
Spurious	0.245%

- While the national average $\sim 0.25\%$ may seem low
 - Counterfeits will always exceed spurious (by definition)
 - Counterfeiting risk will be high for brands with equity/pricing power
- This makes quality produces more vulnerable to counterfeits than the market average



Investigation - What it means?

All proceedings for collection of evidence. It is a systematic, minute and thorough attempt to learn facts about <u>something</u> <u>complex or hidden</u>. It starts when the information in respect of an offence is received.

Investigation



Investigation consist of following steps

- Proceeding to spot
- Ascertainment of facts and circumstances of facts
- Discovery and arrest of offender
- Collection of evidence relating to commission of offence -
 - Recording of statements
 - Search
 - Seizure



Steps Involved

- Gathering of intelligence
- Sifting of information
- Verification
- Commencement of investigation



Methodology

- Confidential purchase of drugs suspected to be spurious
- Confidential testing of these samples
- Comparison with original product
- Wherever possible obtaining opinion of original manufacturer
- Following suspect with the help of watcher or by officer himself
- Decision taken to raid the place or places with or without help of police



Supporting Methodology

- Shortlist medicines that are likely candidates
- Undertake survey sampling on our own or through NGOS
- Keep track of retailers and wholesalers not doing good business
- Watch activities of dealers with bad antecedents
- Frequent inspections of such dealers
- Ideally, study the modus operandi and keep profile on offenders



Complex Issue

Remember

- Manufacture, sale and distribution of spurious drugs is a clandestine activity
- Cases are not noticed during routine inspections
- Normally, complaints do not result in detection of such cases



Therefore, most important pre-requisite is gathering of intelligence of such activities



Vital Ingredients

- Dedicated officers with aptitude for investigation
- Information
- Informants
- Skills of sifting Information
- Speed in investigation
- Interrogation Skill
- Co-ordination Skills



Vital Ingredients

- Teamwork
- Presence of Mind
- Ability to follow clues
- Attention to minor clues
- Patience
- Ability to remain cool

Speed in Investigation

Spurious Corex case

- Received information
- Rushed to spot
- Interrogated the person
- Seized stock of spurious corex with invoice
- Proceeded to manufacturing/residential premises of accused
- Seized stock along with pp caps, colored Xerox label, jar of cough syrup
- Accused arrested
- Completed investigation of label, p.p. caps
- Proceeded to investigate bogus invoice of firm at Satara



Assets of Investigator

- Ability to cultivate informant
- Ability to treat the informant regardless of his character
- Ability to conceal Informants identity not only from his business rivals/associates but also from other officers



Skills to sift Information

- Investigate all the tips
- Evaluate reliability of Information
- Don't be misled by fabricated information



Speed in Investigation

Godrej Hair Dye case

- During search at Mahavir communication center transport receipt of dispatch were found
- Scrutiny of T.R. revealed that Godrej Hair dye was sold to Calcutta, Bangalore, Surat, Delhi
- Team rushed to Batco transport, and withheld stock ready for loading to Surat, Delhi
- Communicated Batco Branch Surat not to make delivery of earlier supply
- Visited to Surat Seized stock at transport and shopkeeper's premises

Essential Skills

Attitude of Investigator:-

- » Never give up
- » Look for clues

R-cin case

- Accused absconded, Telephone bill frequent std calls gave clue to Ladawa Kurukhetra
- Telephone No display on wall in police station help to identify Mr. Ashwin Maheshwari

Glaxo case

- No stock found at Welcome Hindu Hotel.
- Son of accused detained & interrogated
- Stock seized from Andheri Lokhandwala creek



Ability to Interrogate to elicit information/clues

Interrogation is an Art – no set of Rule guide for successful investigation of case

R-cin case

 Accused absconded, persuasion/pressurization of his brother (Licensee) made him produce accused before us

Wyeath Lab case

Recovery of 80 gms Prednisolone

Innovative approach - Mascot Lab Ahmedabad case

 Accused absconded, visit to premises, instructed watchman not to open market, publicity in local news paper helped to get accused surrendered



Communication and coordination

Mascot Laboratories Ahmedabad

- Stuck-up to get transporter address
- Informed A.C. (I.B.) Mumbai
- Officer made inquiry at transporter's premises at Mumbai
- Communicated details Not only address but code number -- modus operandi



Commitment to solve the case and Coordination paid dividends

Satya Narayan Hyderabad Case

- First visit Accused absconded
- After one year visited Hyderabad for another investigation
- Accused was located
- Informed Mumbai office who coordinated with CB II
- C.B. Police arrived at Hyderabad
- Coordination of local Drug Control was sought
- Accused arrested with huge stock of spurious drugs
- Accused was convicted in the case



Teamwork

R- cin case

- Officers assigned to get help from Lupin Laboratories determine R-cin caps are spurious
- I.O. gave FIR, Police Custody transit remand of accused secured
- Co I.O. to make up mind of mediator to go to Delhi who knows culprit – Ravi Sharma
- Other officers coordinated to get air ticket





Teamwork - Presence of Mind

- Officers with mediators managed to board plane in time
- Police team with accused on way to arrive to airport
- Plane was delayed for 10 minutes
- Till the police boarded the plane





Ability to follow clues

Godrej Hair Dye case

- Main accused absconded
- Stuck up to get manufacturing premises
- Telephone bill found in drawer of table
- Interrogate person, premises was found in vicinity of FDA office with full fledged activity of spurious cosmetic mfg

Franco Italian case

- Rough notebook of Analyst reveled true
- M.P. of Sulpha methoxy pyridazine





Patience

- Stock of rejected drugs was seized
- Person arrested disclosed name of Bhavesh as a person who had purchased rejected drugs
- Bhavesh came to know of raid
- Decision taken not raid his place
- He was allowed to believe that he has managed to avoid arrest
- Watch continued for almost fifteen days and then raid was carried out



Patience

Case of Anoop Hair Oil

- Watch maintained for twenty days
- Suspected person was moving on cycle in crowded area of Moh. Ali. road
- Residence located at Andheri
- Not much stock found officers not disheartened
- Interrogation led the team to dealer at Santacruz



UNBELIVABLE - What is this?

Compounds mfg by Bhavesh -Ampicillin Trihydrate, Rifampicin, Erythromycin Stearate

Ability to remain cool

- Bhavesh was present during raid
- But pretended to be his brother
- His mother and sister also supported the story.
 At 19.30 the informant informed the fact Bhavesh ran away
- What happened next?
- Good example of remaining cool






Ability to remain cool

- Accused arrested at 19.00 hrs at Orai
- Put in lockup
- Accused reported chest pain 22.00hrs
- Admitted to Civil Hospital
- Send to admit to Medical College
- CJM Orai refused to give transit remand in absence of accused person
- CJM Jhansi refused to transit remand
- Accused was brought to Orai contacted PP
- Accused was present before CJM Orai
- Ultimately CJM Orai gave transit remand



Spurious Duphaston – Roorkee, Mar 2020






