
1. Covering letter from the manufacturer/exporter on letter head addressed to concerned laboratory.
2. Manufacturing license of the product for export purpose.
3. Export order
4. Representative sample from the export consignment.
5. Thrice the quantity required for performing complete analysis of the sample as per their STP
6. Qualitative composition of product including excipients.
7. Certificate of analysis by the manufacturer of the particular batch, product specification and method of analysis (Spec./STP).

8. Reference/working standard and Placebo as applicable.

In view of above, all State Licensing Authorities/CDSO Zonal, Sub-Zonal Offices and all Indian Drug Manufacturer Associations are once again requested to note the above information/requirements for export of cough syrup.
